2011 Open Day

TrackWest Open Day 26th March 2011

Our Annual Open Day was held on the 26th March at Lumen Christie College, Martin. The day was held to promote tracking to people who had not tried it before. A wonderful crowd of 36 handlers and dogs of all shapes and sizes arrived. President Louise opened the proceedings by introducing all the trainers and giving a brief description of TrackWests aims. Training Co-Ordinator Sue then gave a quick run down of the basic tracking skills. Everyone was split up into groups of 6 with 2 trainers and we ran through how to start tracking by "finding the handler" then "finding the trainer" all the while having fun with our dogs. Many of the dogs were naturals and were soon finding the trainers as if they had known them all their lives. The day was very hot so while we sat in the shade and had morning tea, Judy explained the ins and outs of trialling while Jim and Valeta talked about Track and Search Dog training and the wonderful roast dinners we have at trials. It was great to see such a turn out of well behaved dogs. Thank you to all the trainers who helped out.





TRACKING ETIQUETTE

When entering a Tracking Trial there are many things to consider and do. Here are a few things that may help make things easier for all:

Label your reward with YOUR name, your dog's name and the test you are doing; this helps the stewards and the judges ensure your dog gets the correct reward.

Entry Forms:

Please ensure these are filled out correctly and in writing that can be easily read. Make sure you say which test you are doing

Ensure that you state clearly whether you are available on Wednesday. Depending on numbers, you will probably track on that day but you may be asked to track on Saturday. If you do not say you are available on Wednesday, it will be assumed you can only track on Saturday.

If you need a known tracklayer (Test 1 & Test 2) please place the name of *your* tracklayer on the entry form. If you possibly can, don't name another competitor – your mother, husband, sister, best friend is much better. You can name a teenager provided they are 14+ years old and can follow instructions

If you are doing a test 5 please put down your known cross-track layer.

It isn't the Trial Secretary's job to work out who is a known person for your dog.

If you are going for TD you must have passes under two different judges. Also if you are going for your TDX you must have passes under two different judges (tracks 4, 5 & 6). If you already have two passes with the same judge, please put in a note saying this with your entry. (This makes the trial secretary's job easier. Although the TS keeps a data-base, it is easy to miss)

If you can supply someone else who can lay tracks please let the trial secretary know with your entry. Remember, you are asked to nominate someone who can lay tracks when you put in your entry. Unless you are doing Test 1 or 2, they will not lay a track for your dog. They will be treated like Royalty, though!

Setting off for trial (night before/morning of):

Don't forget your dog's harness, lead and your tracklayer or cross-track layer. Also wet weather gear and possibly a change of shoes (in case it ever rains again)

Ensure you are socked up so that you are ready to lay a track if asked. After all we can't have passes if we don't have tracklayers. You will require 4 socks that are a dark colour (black is good). Put these socks on your body before leaving home.

Dog and tracklayer reward:

When organizing your dog's reward please ensure you don't overload your tracklayer. Your reward for your dog should be small, pocket size, you can always give your dog more treats back at the car. Ensure that your reward will NOT leak. Dogs like sardines but tracklayers **DON'T**, and the pull ring can often break off.

Along with the reward it is nice gesture to leave something for your tracklayer, e.g. small chocolate bar or lolly, lotto/scratchie tickets, thank you note, etc.

Place the dog's rewards and the tracklayer's reward in a zip lock bag. "Glad" zip seal bags are great for this.

Arriving at trials:

Travelling with another person who is tracking a dog can get difficult as there is **NO** guarantee that you will be with the same judge and often you are miles away from one another and could even be on at the same time — judges and stewards don't always have room for you and your dog in the car to cart you around — to try and make things easier please make sure the trial secretary knows this.

Please ensure you arrive on time to the trial. If running late please ensure you call the trial secretary. There is always a mobile number to contact the trial secretary on during trial days.

Some tracks go out half an hour before judging commences so please be early as your track might be one of these and your reward may be required.

Judges often do a talk to all their competitors before judging commences so ensure you are there for this as you will find out the days proceedings.

Some judges will let you know beforehand when and where you will be required. If your judge has done this, follow their instructions.

Upon arrival ensure you check in with the Chief Steward ASAP, with your dog if she requires vetting. If you need directions to the start of your track, the Chief Steward has all that information.

By arriving early if you are the first track on the day you will have time to toilet your dog, relax and have a chat.

Check with the Chief Steward before you exercise your dog. She will direct you to an area away from any tracks.

After your track and the end of the day:

At the end of your track, pass or fail please don't forget to thank your tracklayer, judge and steward: without these people you would not have the opportunity to gain a pass (or even track).

Sometimes tracklayers are dropped off and don't have a car so offer them a ride back to the base camp.

If your track wasn't reflagged while you were tracking please offer to help re-flag your track if needed.

Unlike obedience/agility trials, tracking trials don't have many people around, so please stay until after presentation, to help celebrate the passes and enjoy lunch!

Other important information:

If you are involved in more than one track; ie. Tracking your dog and handling someone else's or tracklaying for others, please be aware that at times, this is a logistical nightmare for the Trial Secretary to co-ordinate. Ideally, you should be involved in only 2 tracks per day (be that handling or tracklaying).
