

IMPORTANT NOTICES

For everyone who is trialing or intends to trial!

(1) For each title (including Champion and Track & Search titles) YOU MUST HAVE PASSES UNDER AT LEAST TWO DIFFERENT JUDGES.

This means that for a TD title your qualifying cards for Tracks 1, 2 and 3 must be from at least two different judges. For TDX, your qualifying cards for Tracks 4, 5 and 6 must be from at least two different judges. For Tracking Champion, your qualifying cards for Tracks 7 and 8 must be from two different judges.

If you already have two cards from the same judge (for example, you are entering for Track 3 and you already have Tracks 1 & 2 from the same judge) PLEASE MAKE SURE YOU WRITE THIS ON YOUR ENTRY FORM – fill in the section at the foot of the entry form or write "not Already have two passes"

(2) If you gain a title, YOU CANNOT ENTER FOR THE NEXT TITLE UNTIL YOU HAVE LODGED THE PAPERWORK FOR YOUR TITLE WITH DOGSWEST. THIS MUST BE DONE BEFORE THE CLOSE OF ENTRIES.

For example, if you pass Track 3, you have gained a TD title. Before you can enter for Track 4, you must lodge your application for the TD title with Dogs West. This means that the paperwork must be given in. If the entries close on the Monday following the Trial, you will need to make a trip to Dogs West to either drop all the paperwork (and fee) in the letterbox (weekend) or hand it in at the office (Monday). "Application for a Title" forms can be downloaded from the Dogs West website. The same applies if you pass Track 6 and want to enter for Track 7.

This rule can create a problem if you gained your final pass for a title on **WEDNESDAY**. **If your pass is gained after entries close (Monday) you will not be eligible to enter the next trial.** On the bright side – there is quite a jump in difficulty from TD3 to TD4 and from TDX6 to Track 7 so missing a trial and getting some extra practice at the higher level can mean the difference between Pass and Fail at that higher level. Otherwise, request to be judged on Saturday.

- (3) Before you can enter a Tracking Trial or handle a dog in a Tracking Trial you must be a member of Dogs West and your dog must be registered with Dogs West. All the information and forms for joining Dogs West are on the Dogs West website. Allow at least a month before you plan to enter for the paperwork to go through you must quote your Membership number and your dog's CAWA registration number on your entry form and Dogs West are notoriously slow.
- (4) When you arrive at a Trial, please go straight to Base Camp before you let your dog out of the car. Ask the Chief Steward or the Trial Secretary where you can exercise your dog so that you don't interfere with tracks.

Evacuation Procedure

In the event of a Fire Emergency please take the following steps

Trainers

Round up your group. If laying or working tracks they must stop immediately and follow you to our entry gate (where we meet in the mornings) and please sign out (or remove your 'entry' flag) before you leave so you can be accounted for.

On trial days the same applies only judges will be in charge of their individual groups of people and once everyone is together to proceed to morning tea area and then move to our entry gate and to be checked out before you leave.

Please always let Chief Steward know if you are training on trial days and where you will be.

Someone will drive around tooting their car horn. This is your signal to immediately stop what ever you are doing and follow the above steps.

In the event of a Medical Emergency

On training days.

One of our First Aid officers will be on duty and will phone an ambulance if required.

Someone will be sent down to our entry point to meet the ambulance. This person will have the location of the medical emergency to guide the ambulance.

Same procedures will occur as for Saturday.

FOLLOWING GHOSTS - THE ART OF TRACKING

Tracking is probably the most fascinating aspect of dog work because it is the only one in which we do not – cannot – tell the dog what to do. They have to tell us! To quote the preamble to the Tracking Rules, "The idea of Tracking (Trials) is to encourage dogs to make use of their strongest faculty by emulating as closely as possible the seeking and finding of a missing person" That faculty is, of course, their ability to detect minute amounts of scent. The description of tracking as "following ghosts" comes from Suzanne Clothier's book of that name and describes it very well.

Our dogs live in a world of ghosts that we cannot see. When we train a tracking dog we do three things

- 1. Teach our dog to follow the scent that we indicate a particular human scent as opposed to kangaroo, rabbit, fox or even another human
- 2. Teach ourselves to "read" our dog so that we can know when our dog is on the scent, when he is unsure and when he is just going in that direction because he thinks we want him to.
- 3. Strengthen our relationship with our tracking dog because we, as handlers, must learn to rely on and trust our dog. This is usually the hardest part of tracking.

All dogs can track – not all dogs want to and this often reflects the relationship you have with your dog. If you can answer, *Yes, most of the time* to the two questions:

Can you work your dog off lead for a short time?

Does your dog come when called?

Your dog will track for you. If you can't, then it is your relationship with your dog that you need to work on first. Some breeds do find nose work less natural – sighthounds (Salukis, Afghans, Whippets, and Greyhounds) and some of the toy breeds can track but require a lot more patience than Working or Gundog breeds. That said, there are brilliant trackers and "slow learners" in all breeds.

Tracking training is about "enjoying the journey". Who else works with your best friend in a beautiful pine forest with the scent of the pines, the songs of birds and the bright faces of wildflowers all around you. Or walks through the same forest, laying a track for someone else. Or sits down with a congenial group of people having a well-earned morning tea. Or the benefits from increased fitness (some of us have been known to walk more than 10 km in a training session).

Who else knows the fantastic feeling of achievement when your dog finds the tracklayer at the end of a 1 km track and the Judge says "Congratulations, you passed". Your dog knows they've done something pretty special, too! There are no first places in Tracking, no trophies, just the graduated series of tests that have to be passed to earn Tracking Dog (TD), Tracking Dog Excellent (TDX) and Tracking Champion (T Ch) titles.

An excellent small book on tracking is "Following Ghosts" by John Rice and Suzanne Clothier. It is the best introduction. It is available direct from Flying Dog Press http://www.flyingdogpress.com or your Library might get it in for you.

To improve your dog's scent work, whether it is Tracking or Obedience or just having fun, Scent Games are great. A really good resource is "Scent Games - Educating Your Dog's Nose" by Suzanne Clothier and John Rice www.suzanneclothier.com/scent-games-educating-your-dogs-nose

The link also gives access to a number of other excellent articles on aspects of dog training, obedience and agility.

Above all, enjoy the journey – the good, the fantastic and the not so good. You have great company along the way – both canine and human!

Awards for Titles:

TrackWest awards those dogs and handlers who achieve a Tracking or Track & Search Title during the year a sash in TrackWest colours of forest green and black. A lot of hard work and dedication goes into obtaining a title; this is TrackWest's way of acknowledging the efforts its members have put into tracking. This year our members achieved 13 TD (Tracking Dog) titles, 15 TDX (Tracking Dog Excellent) titles and 8 T CH (Tracking Champion) titles.

<u>Track & Search</u> is open to dogs with a T Ch. Title. A dog who gains a T&S Grand Champion title has passed 18 tracking tests of increasing difficulty ranging from 400 meters length with 20 minutes delay to 1200 meters on suburban streets with a 3 to 4 hour delay in which the track layer travels in a car for part of the track. The T&S Grand Champion title is an achievement to be proud of. This year TrackWest members gained 6 TSD titles, 2 TSDX titles, 7 TS Ch. titles and 5 TS Grand Champion titles.



1. Dog Control

- Dogs to be on lead at all times.
- No members' dog or dogs shall be off-lead during official training sessions unless being trained and supervised by an instructor.
- Permission may be given by an instructor/official to run your dog off lead, in a specific area.
- No dogs off lead within 50m of base camp.
- Put your dog back on lead 50m prior to returning to your vehicles.
- Dogs must not be left "tethered" to the "outside" of vehicles at any time.
- Vehicles left with the backs open (eg hatchbacks) dogs must be secured.
- Any member not complying with a Request to place their dog back on lead, by a Committee member or instructor, shall be disciplined at the Committee's discretion.
- Members' dogs are not permitted to chase or harass livestock or wildlife.

2. Training

- The person authorized by the Committee may order the removal from the training session of any dog or handler whose conduct is objectionable.
- The Committee shall be empowered to discipline any handler who willfully interferes with another member's training, or another member's dog, or whose behaviour is objectionable.
- Any instances related to the above should be reported to the Committee in writing, within 7 days of the incident.
- Keep to allocated areas
 - For safety reasons the Training Co-ordinator needs to know where you are.
- Access to Gnangara: Check the website and Facebook for regular up-dates.
- **3.** All members are expected to volunteer assistance in line with the Club's statement of purposes and to participate as much as possible in Club activities (i.e. Morning Tea).
- 4. Members should ensure that they remove all rubbish and keep tracking areas clean.
- 5. Members shall take all reasonable steps to maintain cordial relationships with other legitimate users of tracking areas.

6. Vehicle Safety

- Please slow to 20km/hr when passing people, dogs or parked vehicles.
- Keep to the left and slow down when approaching the crest of a hill.


7. Spectators

Spectators must get the permission of the competitor and the Judge prior to following up a track.

8. Trialing

Treats for your dog at the end of track are to be in a sealed container within a sealed bag with your name and dog's name written clearly. Treat to be given to the Judge or their steward and not to be carried on the track.

- **9.** Any member who misappropriates, damages or causes loss or breakage of the Club's property shall forthwith make good any loss or breakages the Committee may direct.
- 10. Club joining fees and membership fees are non-refundable.
